

Agency Appointment and Agreement

THE END USER HEREBY APPOINTS Local Authority Services Limited (LAS), a subsidiary company of the Association of Municipalities of Ontario, as its agent in respect of all matters related to the End User's supply of natural gas. The End User further confirms and accepts the appointment by LAS of a third party to act as agent of the End User for the purposes of managing the End Users gas supply in accordance with a services agreement between LAS and the third party. The third party agent may be changed from time-to-time by LAS, with notice of any change being provided to the end users.

THE END USER ACKNOWLEDGES AND AGREES:

That LAS is authorized to approve one or more Purchasing Strategies for natural gas as developed by the appointed agent. The agent is authorized to negotiate, execute and manage one or more gas supply contracts, delivery agreements, and collection service agreements for and on behalf of the End User for purposes of managing natural gas supply;

That the End User may terminate the appointment of LAS as its agent by providing LAS with written notice not less than 120 days prior to the latest expiry date of any agreements to which the End User has been bound;

That notwithstanding any termination of LAS as agent the End User shall remain liable for all agreements, obligations and purchases made on their behalf under the LAS Natural Gas Program;

IN NO EVENT shall the End User, LAS or the appointed agent be liable to each other or third parties for consequential, incidental, punitive, exemplary or indirect damages, lost profits or other business interruption damages, by statute, in tort (including negligence) or contract, under any indemnity provisions or otherwise. Furthermore, in no event shall the aggregate liability of LAS or the appointed agent to the End User exceed the total amount of the fee received for its services in the twelve (12) month period immediately preceding the event(s) giving rise to the damages.
